I UNDERSTAND AND WILL ABIDE BY THE FOLLOWING CONDITIONS OF THIS CONTRACT:

1. This kitten will be guaranteed for the first year of life on the following conditions only: HCM, SMA, PKD. PKDEF. Southern Coons does not cover monorchidism (one testicle) or cryptorchidism (one retained testicle) in males. We do not cover this as there is no test that can be used to prevent this from happening. The kitten is being sold as pet only and is required to be neutered/spayed at six months or earlier if this is the case.
2. Southern Coons will not be held liable for any vet expenses due to the monorchidism or cryptorchidism **Buyers Signature**
3. This kitten WILL NOT BE COVERED FOR FeLV or FIV as this occurs from contact.

4. Buyer agrees that this kitten will be for pet purposes only and will not come with breeding rights. The kitten will NEVER be sold, leased, given away, put in an animal shelter, humane society, or sold to any pet store.
5. Buyer agrees that the kitten will and shall remain indoors only. This is for the health and safety of the kitten.
6. Buyer agrees to NEVER DECLAW the kitten but can clip the nails every two weeks. Declawing the kitten will result in void/null in this warranty.
7. Buyer MUST QUARANTINE the kitten for 2 weeks from all other household pets. If you expose the kitten to other animals or allow outside the warranty will be voided.
8. Buyer agrees to take the kitten to a licensed veterinarian within 72 hours of the buyer's possession. **Buyer Initial** \_\_\_\_\_
9. Buyer agrees that the seller is not responsible for any vet care or continuing vet care. **Buyers Signature** \_\_\_\_\_
10. Buyer agrees to forward the full health exam and notes of the original copy of the initial vet exam to the breeder. The receipt must include the name of the hospital, vet name, address, phone, fax number, buyers name, address, date of service, feline breed, and color along with all the findings.
11. Kittens picked up between 12-14 weeks must spay/neuter before 6mths of age in order to receive the registration paperwork. Registration papers will also show "not for breeding". Kittens sold 6mths and older will be spayed/neutered before leaving my home. FAILURE TO ADHERE TO THIS WILL RESULT IN \$3,000 FINE AND SETTLED IN SMALL CLAIMS COURT IN FRANKLIN COUNTY, CARNESVILLE, GA. **Buyer Signature** \_\_\_\_\_
12. Buyer must be patient with the kitten as it acclimates to the new environment and new owners. Buyer is not to expect the kitten to show too much affection immediately.
13. This cat/kitten has been vet examined before leaving my home and will come with the health certificate showing the kitten is in good health and free of signs of illness.
14. The cat/kitten has been given both 3-way vaccines. (Only one will be given if the kitten has an allergic reaction to the first one. \*\*Note: your cat/kitten requires more vaccines to maintain his/her health. Rabies at 16 weeks) **Buyer Initials** \_\_\_\_\_
